



## MusicOne Youth Attendee Release and Waiver of Liability

PLEASE READ CAREFULLY.

THIS IS A LEGAL DOCUMENT THAT INCLUDES A RELEASE OF LIABILITY AND AFFECTS THE LEGAL RIGHTS OF THE MUSIC ONE YOUTH ATTENDEE AND THOSE OF ALL PARENTS/GUARDIANS

This Release and Waiver of Liability (the "Release") is executed on this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by \_\_\_\_\_ (the "Youth") and by \_\_\_\_\_ and \_\_\_\_\_ the Youth attendee's parent(s)/guardian(s) (the "Parent(s)/Guardian(s)") in favor of MusicOne, a DBA of the non-profit Lake County Youth Services Inc., any other MusicOne affiliated organization including but not limited to Pyramind Inc., and each of their respective directors, officers, trustees, employees, volunteers, and agents (collectively, the "Released Parties"). The Youth Attendee and the Parent(s)/Guardian(s) are collectively referred to as "We."

I, the Youth Attendee, want to attend the MusicOne Meet the Advisory Benefit Concert ("Event Activities"). The Parent(s)/Guardian(s) elect to allow and hereby consent to the Youth's participation and attendance in the Event. The Youth's participation in the Event Activities is purely voluntary and without compensation.

**Event Activities.** We understand that the Youth's activities may include but are not limited to the following: viewing and engaging in the performances, speeches, viewing and consumption of printed materials, viewing and consumption of video media, listening and consumption of audio, and otherwise distributed media at the Event.

**Nature of Event Activities.** We understand that while minimized by Released Parties, there is inherent risk in the Event Activities the Youth is participating in. We acknowledge and agree to the visual and auditory consumption of all visual media, audio (including but not limited to pre-recorded songs, live performances, and speeches by the Released Parties), as well as any voluntary participation in group activities and organized Event Activities as directed by staff.

We hereby freely, voluntarily and without duress execute this Release under the following terms:

- 1. Release and Waiver.** WE, the Youth and the Parent(s)/Guardian(s), DO HEREBY RELEASE, INDEMNIFY, WAIVE ALL LIABILITY, AND FOREVER DISCHARGE AND HOLD HARMLESS THE RELEASED PARTIES and their successors and assigns from any and all liability, claims and demands which We or our heirs, assigns, next of kin or legal representatives may have or which may later accrue with respect to any bodily injury, personal injury, illness, death or property damage which arises or may later arise from or is in any way related, directly or indirectly, to the Youth's Activities with any of the Released Parties, whether caused wholly or in part by a danger on the premises (whether known or unknown), by the breach of any warranty, by the simple negligence, fault or other misconduct (other than intentional, grossly negligent, or willful and wanton conduct) of any of the Released Parties or of other volunteers.
- 2. Assumption of the Risk.** The Youth and the Parent(s)/Guardian(s) hereby state their understanding that the Youth's Activities may include the risk of injury or loss. Fully aware of this and the Event Activities THE MEMBER AND THE PARENT(S)/GUARDIAN(S) HEREBY EXPRESSLY AND SPECIFICALLY ASSUDEATH,E RISK OF INJURY, HARM, AND LOSS IN ANY WAY RELATED TO THE ACTIVITIES AND RELEASE THE RELEASED PARTIES FROM ALL LIABILITY FOR ANY LOSS, COST, EXPENSE, INJURY, ILLNESS, DEATH OR PROPERTY DAMAGE RESULTING DIRECTLY OR INDIRECTLY FROM THE ACTIVITIES, REGARDLESS OF WHEN THEY BECOME KNOWN.

- 3. **Insurance.** We understand that, except as otherwise agreed to by the Released Parties in writing, the Released Parties are under no obligation to provide, carry or maintain health, medical, travel, disability, or other insurance coverage for any Youth. Each Youth is expected and encouraged to obtain his or her own health, medical, travel, disability, or other insurance coverage. We also understand that the Released Parties do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death, or property damage.
- 4. **Confidentiality.** In the course of the Youth’s Activities, We acknowledge that we may receive personal, privileged and/or confidential information concerning partner families, affiliate issues, personnel, the organization’s operations or other individuals and organizations with whom MusicOne is associated. We agree not to disclose this information and to ensure that this information remains confidential, regardless of whether the Youth is actively engaged in volunteer activities or the Youth’s involvement with MusicOne has ended for any reason. We hereby pledge to keep private and confidential all such information.
- 5. **My Conduct.** I, the Youth, promise to conduct myself in a safe, courteous, and responsible manner and to follow the instructions of those in control of the Event Activities.
- 6. **Other.** The Youth and the Parent(s)/Guardian(s) expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California. We further agree that in the event any clause or provision of this Release is invalidated by any court, the invalidity of such clause or provision shall not otherwise affect the remaining clauses or provisions of this Release, which shall continue to be enforceable. Further, the Released Parties’ waiver of a right under this Release in one instance does not prevent the exercise of that right in the future, should the circumstance arise again, or the exercise of any other right available under this Release.

To confirm that We have read and to express our understanding of an agreement with this Release and Waiver of Liability, We have signed below. All available parents and guardians must sign this Release form before it can be accepted. If only one parent or guardian is available to sign this Release, then the undersigned parent or guardian of the Youth hereby covenants, warrants, represents and agrees that he or she is executing, and has the authority to execute, this Release on behalf of, and as an agent for, the Youth and every other parent or guardian of the Youth, and that by executing this Release, the undersigned is binding, and has authority to bind, himself/herself, the Youth, and every other parent or guardian of the Youth, and all of their heirs, executors, personal representatives, assigns and estates to this Release.
