- 6. Other. The Youth and the Parent(s)/Guardian(s) expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California. We further agree that in the event any clause or provision of this Release is invalidated by any court, the invalidity of such clause or provision shall not otherwise affect the remaining clauses or provisions of this Release, which shall continue to be enforceable. Further, the Released Parties' waiver of a right under this Release in one instance does not prevent the exercise of that right in the future, should the circumstance arise again, or the exercise of any other right available under this Release.
